THE COMPANIES (AMENDMENT) REGULATIONS 2024 made by the Minister by virtue of the powers contained in section 527 of the Companies Act 1995, No. 18 of 1995

1. Citation

These Regulations may be cited as the Companies (Amendment) Regulations, 2024.

2. Interpretation

In these Regulations, “the principal Regulations” means the Companies Regulations 1997, No. 5 of 1997.


